**INDEPENDENCE CRITERIA**

All members of the Electoral Committee and Electoral Appeal Committee shall be independent. They shall not be considered independent if, at any time during the four years preceding their terms, they or any family member (spouse, children, stepchildren, parents, siblings, related parties, parents of spouse/related parties and siblings and children of related parties):

- a) held any paid position or material contract (directly or indirectly) with FAS and or any Member/Confederation, League or Club (including any of their affiliated companies / organisations);
- b) was employed by FAS's outside legal counsel or by FAS's auditor (and was engaged in auditing FAS);
- c) held any paid or voluntary position with a non-profit organisation to which FAS and/or any Member, Confederation, League or Club makes annual payments in excess of USD 100,000.

Article 44.5 and 46.5 of the FAS Constitution refers.

All candidates seeking consideration by the FAS for election to the FAS Electoral Committee or Electoral Appeal Committee are required to attach the following documents:

- Copy of NRIC (Front and back)
- Copy of Passport (Passport details page)
- A Recent Coloured Passport Size Photograph
- Detailed Curriculum Vitae (To include personal details, work experience, academic qualifications)
- Form 2 (Declaration of Integrity)

The above-listed documents form an integral part of this form and the contents of all documents shall be in English.

Any material information which is provided in this form and the attached documents and subsequently found to be incorrect or false, and/or the non-submission of any of the documents may lead to the rejection of the application by FAS.
