- Insolvency Clearance Record

Candidates for the respective office of the President, Deputy President, Vice President or Council Member shall produce relevant documents or proof if any, to satisfy the criteria for the respective offices of the Council. For example, for the office of the President the candidate shall provide proof that he has played an active role in association football (eg as board member, committee member, or an official within FIFA, a confederation, an association or an Ordinary Member of FAS) for two (2) of the last five (5) years before being proposed as a candidate.

The above-listed documents form an integral part of this replacement form and the contents of all documents shall be in English.

Any material information which is provided in this replacement form and the attached documents and subsequently found to be incorrect or false, and/or the non-submission of any of the Documents may lead to the rejection of the nomination by the Ad Hoc Electoral Committee.
